

CONDITIONS OF TENDER AND CONTRACT

N.B. - Bidders should read these conditions carefully and comply strictly while sending their bids

01. **Bidders** must be enclosed in a properly sealed envelope according to the directions given in the bid notice and as per tender conditions. Bid should be marked bid Number and Date of opening on the left hand top corner of the envelop.
02. The rate must not be altered and the rates must be entered in words as well as in figures.
03. **Bidders** should be given by the transport company's/Packing Agencies /Commission Agents. Who are dealing actually in the goods for which bid is being given.
04. The transport/Packing Agencies /Commission Agents, shall not assign or sub-let his contract or any substantial part thereof to any other agency.
05. (a) The purchase Officer or his duly authorized representative shall at all reasonable time have access to inspect whether goods which are to be transported are properly packed or not.
(b) The bid shall invariably furnish complete address of the Branch Offices/Transport Companies by which goods is to be delivered at various districts Transport Godown. Payment shall be made after receipt of proper Bilty and Bills, within a period of one month.
06. The **Bidders** shall be responsible for the proper shortings & packings so as to avoid damage under normal conditions of transport.
07. All rates quoted must be concerning Districts Company's transport godown & should include all other charges.
08. The bid should be filled in with ink. bid filled in by pencil or otherwise shall not be considered. No. additions and alterations should be made in the bid No over writings should be done. Corrections, if any should be clearly initialed.
09. Successful **Bidder** will have to execute on agreement on non- judicial stamp of Rs 500/- in form 17 within a period of 7 days of receipt at order and deposit security equal to 5% of value of the service for which bid is accepted.
10. The **Bidders** should sign the bid form at each page at the end in token of the acceptance of all the terms and conditions.
11. The validity period and the dispatch period may be extended., if mutually agreed both parties.
12. When the **Bidder** is unable to complete the dispatch in the specified or extended period., the dispatching Officer shall be entitled to dispatch from elsewhere without notice to the **Bidder** Recovery for the liquidated damages shall be made as per G.F. & A.R.
13. The goods will be dispatched to district transport Company's godown in perfect conditions. Any loss it occur will be born by **Bidder** The transporters if desire, may insure the valuable goods agains loss by theft, destruction, or damage by fire, flood etc.
14. Direct or indirect canvassing on the part of **Bidders** or their representative will disqualify the bids
15. The Government reserves the right to accept any bid not necessarily the lowest bid or reject any bid without assigning any reason.
16. All legal proceeding, if necessity arises to institute by any of the parties (Government or Transport Co.) shall have to be lodged in Courts Situated in jaipur jurisdiction and not else where.
17. No other conditions except those mentioned as above will be entertained in the bid
18. Weight should not be less than 40 Kg. if bundle more than one.
