**Minutes of 3rd Meeting of State Level Implementation and Monitoring
Committee for SDGs**

3rd Meeting of State Level Implementation and Monitoring Committee for Sustainable Development Goals (SDGs) held on 5th March, 2021 under the Chairpersonship of Chief Secretary. List of the officers participated in the virtual meeting is enclosed at annexure 'A'.

At the outset, Secretary, Plan apprised about the SDGs agenda, institutional framework & initiatives taken at National and State level and progress made so far in the State.

After detailed deliberations on agenda points following decisions were taken in the meeting:-

Agenda 1 – Action Taken Report/ Progress Status of the last meeting of the Committee held on 10th January, 2020.

- Committee accepted the ATR of second meeting.

Agenda 2 – Approval of Rajasthan Sustainable Development Index, 2021 (Ver.2.0)

- Committee approved the Rajasthan Sustainable Development Index, 2021 (Ver. 2.0) comprising of 55 indicators covering 13 SDGs.

Agenda 3- Approval of SDGs State's Status Report, 2021 (Ver. 3.0)

- Committee approved the SDGs State's Status Report, 2021 (Ver.3.0) which includes current status of State on National Indicators of MoSPI and Schematic Indicators of NITI Aayog.

Agenda 4- Discussion on Draft/ Proposed State Indicator Framework

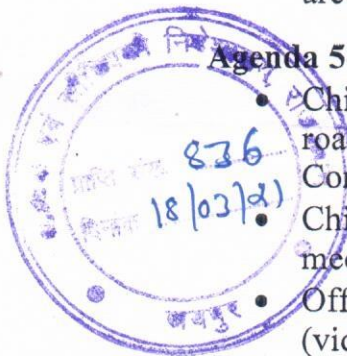
- Committee approved the State Indicator Framework, comprising of 330 indicators, which includes 235 National Indicators, 64 Schematic Indicators and 31 indicators are State specific.

Agenda 5- Review of Sectoral Working Groups

- Chief Secretary directed that all Sectoral Working Groups should finalize SDG roadmap and strategy as per their ToR and submit the report to State Level Committee by 30th June, 2021 positively.
- Chief Secretary also directed that Sectoral Working Group-2 to convene their first meeting before 30th March, 2021.
- Officers in-charge and associated officer nominated by the Planning Department (vide order no. F.4(2)Plan/Gr.-4/2017 dated 18.09.2019) will coordinate with the




concerned convener and Chairperson of the Sectoral Working Group to expedite submission of their reports.

Agenda 6- Other Decisions

- Localization of SDGs and participation of all stakeholders is necessary to achieve SDG agenda and their targets. Therefore,
 - Department of Panchayati Raj and Local Bodies Department (LSG) should organize workshops for orientation and sensitization of district and block level officials and all elected representatives.
 - All departments in coordination with “Centre for SDG Implementation” should organize virtual workshop for orientation and sensitization of district level officers.
- Proposals for dedicated manpower for “Centre for SDG Implementation” should be processed on file separately.
